

SPSS Belux Public Training Terms and Conditions

- In order to book on the SPSS Public Training Course (including Web-Based Training ("WBT")) of your choice you must complete the SPSS Education Order Form either online at <http://www.spss.com/be/training> or send your completed form to SPSS at the address indicated on the SPSS Education Order Form. Your registration will be confirmed once the completed SPSS Education Order Form is received and accepted by SPSS.
 - An invoice will be sent to you upon confirmation of your booking and is payable within thirty (30) days of the date specified on the SPSS invoice. If your invoice address is outside of Belgium then full payment is required at the time of booking. Any payment required hereunder that is made late (including unpaid portions if incomplete payment) shall bear interest at the rate of one and a half percent (1.5%) per month or the maximum rate permitted by law.
 - All SPSS Public Training Course places are subject to availability.
 - All SPSS Public Training Courses (excluding WBT) take place at the location specified on the SPSS Education Order Form. SPSS reserves the right to change the location, you shall have the right to cancel your training course within 10 days of receiving the notification without incurring any charges if the new location is not suitable
 - SPSS reserve the right to cancel advertised courses or amend the public training schedule for any reason at any time. In this event, you will be given the option to re-book your course at another time or will be offered a full refund (excluding any expenses occurred).
 - SPSS shall own all copyrights, patents, and other intellectual property rights in or associated with any training (and WBT) materials which may be provided to SPSS Public Training Course attendees.
 - If you wish to cancel any SPSS Public Training Course (excluding WBT) for any reason (including sickness and transfer of course/date), we will apply the following terms:
 - more than 4 weeks notice 100% refund
 - more than 2 weeks notice 50% refund
 - less than 2 weeks notice no refund
 - All cancellations must be made in writing (including email to belgiumtraining@spss.com) and will take effect from the date of receipt. Refunds are based on the amount originally invoiced including any discounts applied at that time.
 - Nothing in these Terms and Conditions shall exclude or limit SPSS' liability for (i) death or personal injury caused by its negligence (ii) deceit (including without limit, fraudulent misrepresentation) or (iii) any liability that cannot be excluded by law.
 - SPSS makes no warranty with respect to the Public Training Courses. You are responsible for ensuring that you select the Public Training Course which meets your needs and for ensuring that you meet any recommended pre-requisites. SPSS accepts no responsibility for any actions taken by you as a result of any training received from SPSS.  - Save as provided above SPSS shall have no liability to you for any of the following losses or damage (whether such losses or damage were foreseen, foreseeable, known or otherwise): (i) loss of revenue (ii) loss of actual or anticipated profits (iii) loss of business, (iv) loss of opportunity, (v) loss of goodwill or reputation (vi) loss of, damage to or corruption of data, (vii) loss of anticipated savings or (viii) any indirect or consequential loss or damage (including, for the avoidance of doubt, where such loss or damage is of the type specified in this Clause (i) to (viii)) and, in each case, whether such losses or damage are caused by or arising from breach of contract, negligence or other tort, or otherwise.
 - Save as is provided in Clause 9 and subject to Clause 11, SPSS liability arising under these Terms and Conditions shall in no event exceed the amount paid or payable for the Public Training Course to which the claim relates.
 - SPSS shall not be liable for delays or non-performance of any Public Training Course occasioned by strikes, fires, accidents or other causes beyond the control of SPSS.
 - If a part of these Terms and Conditions are held unenforceable or invalid or prohibited under law, it shall be struck from these Terms and Conditions and shall not affect the enforceability of the other parts of these Terms and Conditions.
 - These Terms and Conditions shall be interpreted under the laws of Belgium and the parties submit to the exclusive jurisdiction of the Belgian courts.
 - SPSS shall have a right to assign or transfer these Terms and Conditions to International Business Machines Corporation (IBM) or an IBM subsidiary without your consent.
- ### Special Terms relating to Corporate Card/Five Day Card
- Corporate Cards and Five Day Cards are valid for 12 months ("Validity Period") from the date of purchase (i.e. submission of this form to SPSS) and are non-refundable once purchased.
 - Each Corporate card unit is the equivalent of one day of public training for one person. Cards are not transferable and can only be used by staff of the participating organisation and must be signed by an authorised signatory.
 - Corporate Cards can be redeemed against any public training course listed on the training schedule.
 - To book your place on any of the Public Training Course(s) using a Corporate Card or Five Day Card, please complete the SPSS Education Order Form and quote your reference number.
 - Corporate Cards/Five Day Cards credit unused at the end of the Validity Period will not be refunded or carried over.
 - The use of Corporate Cards and the Five Day Cards as payment for a course disqualifies the attendee from receiving any other discounts that may otherwise apply.
 - Course places are subject to availability and it is the responsibility of the participating organisation to book places within the Validity Period.
 - Corporate and Five Day Cards can only be redeemed against Public Training Courses offered by the SPSS office in the country where the Corporate or Five Day Card was purchased.
 - The Five Day Card is only valid for the person named on the SPSS Education Order Form, irrespective of whether payment is made by the individual or their organisation.
 - The Five Day Card is not transferable between individuals and only the individual nominated on the SPSS Education Order Form will be entitled to attend the five days of public training.
 - No cash refunds will be available to Corporate Card and Five Day Card holders, they will have the appropriate number of days allocated back and will be made available for future course bookings until the end of the Validity Period of the Corporate Card or Five Day Card..
 - In the event Client breaches any of the provisions relating to use of the Corporate Cards or Five Day Cards SPSS reserves the right to cancel any remaining credit or days immediately, without refund of the remaining value.
